MONTE RIO UNION SCHOOL After School Program 2014-2015 Rules of Conduct

**EVERY student enrolled in Monte Rio After-School Program MUST have a signed form on file. (Children and parents need to review this information together and sign below)

Students Must:

- Report to B101 or B103 for attendance sign in, stay with assigned group at all times and inform staff before leaving assigned area. Students need permission to go to teachers' classrooms.
- Students may not roam the campus or wait in parking lot for parent pick up. Students will not be permitted to leave program area without an authorized adult.
- Listen to program instructors and follow directions.
- Use appropriate language at all times.
- Students shall keep hands to themselves and maintain self control. This includes, but is not limited to, getting in another students' personal space, distracting other students, and touching another student in any way.
- Take care of their own belongings, keep track of own materials.
- Use equipment and supplies in a safe and appropriate manner and only after being instructed to do so by the A.S.P Staff.
- Respect school property and any destruction of property will be severely reprimanded. This includes, but is not limited to, graffiti, breaking &/or removing of supplies, and leaving trash behind.
- After School Staff are to be treated with the same respect given to classroom teachers.
- Students should immediately report any teasing and/or bullying to their parents and class instructors. Teasing and bullying are grounds for immediate enrollment termination.
- Follow all day time School Rules
- Play safe and have fun!

Parents Must:

- Recognize that Monte Rio After School Program requires a mandatory 1 hour of homework time, we offer homework support and academic enrichment, however following up with your child each night is vital.
- Complete and submit appropriate paperwork for registration and update emergency contact information as needed.
- Be on time to pick up children. Parents must check in with staff when picking up students and sign students out in our attendance binder. Students must be picked up no later than 6:00 p.m. (Please see Late Pick-Up Policy).
- Students will not be permitted to leave the program area without an authorized adult.

We have read and understand these rules of conduct and agree to uphold them to maintain a safe and enjoyable after-school program for every student. We understand that the success and continuation of the Monte Rio After School Program is dependant upon parents and students adherence to these policies. Failure to cooperate with these rules and expectations may result in denial of program participation.

School Bus Rules

The Monte Rio Union School District has adopted rules and regulations for school bus riders. These rules will assure safe and proper travel to and from school and are to be observed while waiting at bus stops, riding the bus home and to school, or on field trips. The following list of student actions constitutes violation of the established rules and regulations:

- Anybody contact (slapping, hitting, poking, shoving, pulling hair, etc.).
- Fighting on the bus, or at the bus stop.
- Using other than the students regularly designated stop without proof of parental permission.
- Using bad language or obscene gestures.
- Using unauthorized exits (from emergency doors, windows, etc.).
- Putting any part of the body out of the bus window at any time.
- Any movement out of the seats while the bus is in motion.
- Riding the bus after being denied the riding privilege.
- Obstructing the aisle with legs, feet or other objects, or facing to the rear in the seats.
- Creating distracting noise.
- Any improper bus stop procedures (rock throwing, playing in the streets, any property damage at bus stops, etc.).
- Unauthorized opening, closing, or tampering of any kind with bus doors, windows, or emergency exits.
- Damaging or defacing of a bus.
- Littering of any kind.
- Transporting live animals, reptiles, or insects inside the bus.
- Eating, or drinking on the bus.
- Lighting matches or any other combustible.
- Throwing objects of any kind on or from the bus.
- Disrespecting the driver.
- Transporting any object the driver feels is unsafe.
- Giving improper identification when requested by driver.
- Tampering with bus controls.
- Failing to obey the driver.
- Failing to remain quiet at all railroad crossings.
- Exhibiting other unauthorized or unsafe actions.

Failure to observe bus rules may result in denial of bus transportation.

School Bus Safe Riding Practices

A parent's written permission slip is required if a student is to ride to a stop other than their regular stop. Students are oriented by their regular driver regarding basic expectations. Students receive training in safe riding practices and evacuation of a school bus. Classroom behavior is expected on all school busses. By law, students must remain seated at all times, must keep body parts inside the windows of the bus, and must follow all directions of the driver. The driver is responsible for the safe transportation of passengers, so the fewer distractions, the safer the ride will be. Students who are waiting for the bus at their stop must be extra cautious of traffic and stand is a safe place. When exiting a bus, students should walk away from it as quickly as possible within the view of the driver or driver's mirror. Please instruct your child that if he or she drops papers or books, to walk away from
